Tan Chorh Chuan

Professor Tan Chorh Chuan was appointed President of the National University of Singapore in December 2008. He previously held the positions of NUS Provost, then Senior Deputy President from 2004 to 2008.

Prof Tan played a key role in setting up the Duke-NUS Medical School, in his capacity as Deputy Chairman of the Governing Board from 2005 to 2008. As the inaugural Chief Executive of the National University Health System in 2008, he brought the NUS Medical and Dental Schools and the National University Hospital under single governance.

Prof Tan is a key leader in Singapore's Biomedical Sciences Initiative since its inception in 2000. He had played an instrumental role in leading the public health response to the 2003 SARS epidemic in his capacity as the Director of Medical Services, Ministry of Health. He is also the first Singaporean to be elected as an international member of the US National Academy of Medicine.
